Quality Assurance Reviews are BACK!

Quality Assurance Reviews are a changin...

- ▶ QARs will be individualized for your agency
- ▶ Formerly MBCC reviewed a random sample of 10% of incidents
- ▶ The reviewer went over FBI priorities for the second part of the review
- ▶ Issue resolutions
- ▶ Follow-up

How will the QAR flow?



A notice will be sent at least 30 days prior

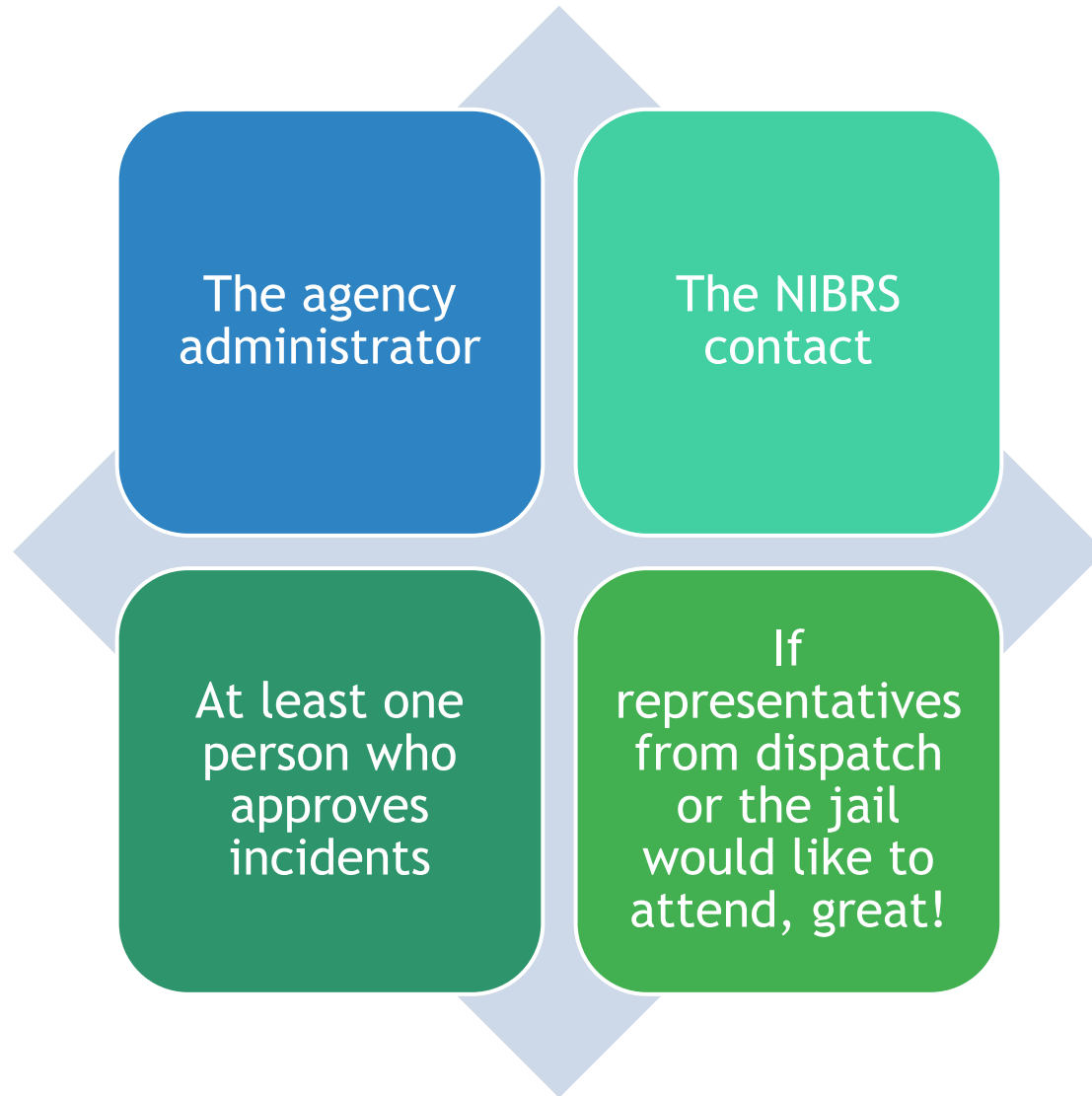
- ▶ The notice will include the “agency health report”
- ▶ The health report will include several reports with areas of concern highlighted
- ▶ Of the issues identified in the reports, a maximum of 8 issues will be prioritized in the notice
- ▶ If an issue requires further data, that will be requested
- ▶ The meeting may be face-to-face, zoom or desk review
- ▶ Maximum of 3 hours
- ▶ Follow-up as identified in the QAR summary

Your agency's health screening

- ▶ Reports for your agency
- ▶ Comparing results over time
- ▶ Reviewing NIBRS sticking points - errors/warnings
- ▶ Comparing your agency to others with similar numbers of sworn and civilians
- ▶ Comparing your agency to others serving similar size jurisdictions
- ▶ Highlighting what we know... good or worth noting
